| <p>Important Notice for USEF RECOGNIZED SHOWS:</p> <p>LIFE, SENIOR ACTIVE AND JUNIOR ACTIVE MEMBERS SHALL BE ELIGIBLE TO PARTICIPATE IN ALL CLASSES AT REGULAR COMPETITIONS, EVENTING COMPETITIONS AT THE PRELIMINARY LEVEL OR ABOVE AND COMBINED DRIVING COMPETITIONS AT THE ADVANCED LEVEL, DRESSAGE AND VAULTING COMPETITIONS AND ENDURANCE RIDES PROVIDED THE RESPECTIVE BREED/DISCIPLINE DUES OR BREED/DISCIPLINE CATEGORY FEE HAS BEEN PAID. A NON-MEMBER MAY PARTICIPATE AS A HANDLER, RIDER, DRIVER, OWNER, LESSEE, AGENT, COACH OR TRAINER AT REGULAR COMPETITIONS, EVENTING COMPETITIONS, DRESSAGE COMPETITIONS AND COMBINED DRIVING COMPETITIONS UPON PAYMENT OF A \$20 NON-MEMBER REGISTRATION FEE AND A \$5 BREED/DISCIPLINE CATEGORY FEE FOR EACH BREED/DISCIPLINE. USEF Release, Assumption of Risk, Waiver and Indemnification
This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). I AGREE to release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Federation Rules about protective equipment, including GR318 and EV113, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that "the Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form. *BOD 1/16/05 Effective 12/1/05*

Idaho Dressage & Eventing Association's RELEASE OF LIABILITY For IDEA-Sanctioned Competitions

Please read carefully: I understand that horse activities, including shows, are high risk sports and involve inherently dangerous risks of serious injury and death. I am participating in this horse show at my own risk. In consideration of IDEA's sponsorship and organization of this horse show, I hereby assume this risk, and further do hereby on behalf of myself, my executors, administrators, heirs, next of kin, successors and assigns: (1) release and hold harmless the organizer, organizing committee, judges, officials, IDEA, it's officers, directors, agents, and volunteers, (collectively referred to as "Releasees"), from any and all liability for acts or omissions resulting in accidents, damage, death, injury, or illness to myself and to my property, including the horse or horses which I will compete at this horse show; and (2) indemnify the Releasees from any and all liabilities or claims made by other individuals or entities as a result of my actions, or the actions of my horse, during this event. Warning: Under Idaho law, an equine activity sponsor is not liable for injury to or the death of a participant or equine engaged in equine activities resulting from the inherent risks of equine activities. No participant or participant's representative may maintain an action against or recover from an equine activity sponsor or an equine professional for injury to or the death of a participant or equine engaged in an equine activity or resulting from the inherent risks of equine activities. See Equine Activities Immunity Act, I.C. § 6-1801, *et seq.* This agreement shall be governed by the laws of the State of Idaho. This Release of Liability shall be construed broadly to provide a release and waiver of liability to the maximum extent permissible under law. I hereby certify that I have read this agreement, and I understand its contents.
